62nd Precinct

Captain Sanseverino, the Commanding Officer of the 62nd Precinct, spoke regarding ongoing investigations of massage parlors. He stated that there have been multiple arrests at approximately 33 locations throughout the district.

District Manager's Report

Marnee Elias-Pavia advised that the Department of Parks awarded the bicycle concession at Bensonhurst Park. The concessionaire has included surreys, which was not specified in the request for proposal. She has requested a meeting with Parks to discuss potential user conflict on the bicycle path.

The District Manager advised that our office recently received notification that due to an electrical issue the comfort station at Garibaldi Playground had been closed for several weeks. Con Edison has provided temporary electric service and the bathrooms have been re-opened.

She further advised that National Grid will be conducting gas construction on 86th Street from Bay 11 Street to Bay 17 Street, 18 Avenue between 85 and 86 Streets, 83 Street from 19 to 24 Avenues, Avenue S between West 3 Street and Van Sicklen Street.

The Bensonhurst Greenmarket located on 18th Avenue between 81 and 82 Streets, reopened on June 4th and will be open every Sunday through November 19th, from 9AM to 4PM.

The Department of Transportation has advised that a new traffic signal will be installed at the intersection of Avenue S and West 3 Street. The work is tentatively scheduled to be completed by September 30th.
